Sub: Indefinite Strike Call of Federations, Teaching and Non-Teaching Staffs of OFB Schools at this juncture — Seeking your guidance.

R/ Sir,

We the Teachers of various Ordnance Factory Schools had discussion regarding the likely corporatization of OFB and the details are given below:-

- OFB is having overall 24 Schools Primary, Secondary, Senior Secondary. The schools are playing a major role in delivering the proper education to all the factory employees and their dependents along with 25% poor and weaker sections as per RTE 2009, implemented in OFB in 2012.
- Near about 15000 poor and needy students are getting proper education in these schools as social accountability
  of Central Government.
- Most of the Ordnance Factories are located in the remote areas and O.F. Schools are only schools to cater education needs. No Fee is charged up to Class VIII.
- 4) Among the 41 Ordnance Factories the teachers are in very small quantity. There are only 585 posts PGT-36, TGT-1 312, HM(P) 22, TP-197 and Lab Attendant -18. As the corporatization steps are fast ongoing, it's creating a serious concern to all the teaching and Non-Teaching School staffs in this organisation regarding 3P ( Pay, Promotion and Pension ).
- 5) The Schools hardly utilize below than 1% of the overall budget of OFB. Hence, Schools are not overhead for OFB or Government.
- 6) OFB Schools should not be treated as a profitable organization whereas it should be treated under welfare units.
- The OFB Schools are nothing without Ordnance Factories. So, our Association took a decision to oppose the move
  of corporatization of OFB organization.
- B) If corporalisation comes in OFB, the schools should be kept apart. We should be consulted before any major policy change.

With reference to the above referred minutes of the meeting dated 16.07.21, I want to raise my concern regarding future of schools being run by OFB and their teaching staff as well as the students. In the aforesaid meeting many issues related to the post corporatization future aspects of different non-production entities of OFB but nothing has been discussed specifically about OF Schools.

Sir, I want to draw your kind attention to the fact that currently 24 schools (Primary Secondary and Higher Secondary) are running in different states with 593 teaches (From Pay level 6 to 10) and lump sum of 15000 students. And the future of all these teachers and students is uncertain in lack of any decision.

It is pertinent to mention that the schools are running under different state boards and serving in remote places as per right to Education 2009 and as per the guidelines of Gol. Most of the students are from BPL and EWS background, basic education of such children will be adversely affected specially of remote areas where elementary education is only provided by OF Schools.

It has been circulated in public domain that all non production entities such as Hospital staff, training institutes etc. will report to the Directorate of Ordnance(to be formed) but nowhere and nothing has been mentioned with regard to the schools.

Disturbance in school functioning will not only affect the future of the society but also leave an army of depressed teachers, who have served the country with their knowledge and teaching skill. In view of all these it is requested to kindly discuss the matter of schools specifically in the upcoming meetings and ensure the future of teachers and the students who are studying in these schools.
